In connection with the dividend payments of \$0.0376 and \$0.041 per common share (ex dividend date February 1, 2023) payable on February 1, 2023 to shareholders of record on January 31, 2023 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 8% of such dividend will be a return of capital, 92% ordinary income (including short-term capital gains) and 0% long-term capital gains.
