In connection with the dividend payments of \$0.0425 and \$0.046 per common share (ex dividend date November 1, 2023) payable on November 1, 2023 to shareholders of record on October 31, 2023 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 22% of such dividend will be a return of capital, 78% ordinary income (including short-term capital gains) and 0% long-term capital gains.
