

## OVERVIEW

The PortfolioPlus S&P 500® ETF seeks daily investment results, before fees and expenses, of 125% of the performance of the S&P 500® Index. **There is no guarantee the fund will meet its stated investment objective.**

This leveraged ETF seeks a return that is 125% the return of its benchmark index for a single day. **The fund should not be expected to provide 1.25 times the return of the benchmark's cumulative return for periods greater than a day.**

## TARGET INDEX

Standard & Poor's® selects the stocks comprising the S&P 500® Index (SPXT) on the basis of market capitalization, financial viability of the company and the public float, liquidity and price of a company's shares outstanding. The Index is a float-adjusted, market capitalization-weighted index. **One cannot directly invest in an index.**
